2) Posting compliance was met per Open Meetings Law.

Medical Examiner. (Hinze)

According to policy, once earned comp time reaches 40 hours it is considered maxed out and can no longer be replenished and would need to be paid out as overtime. Discussion. Is the overtime already embedded into the wages and benefit lines in the EM account. In a phone call made by Ms. Cupery, the overtime is not embedded into the budget. Johnson is to follow-up with Accounting for information about overtime and how it should be incorporated into the 2018 budget.

From the email, the group's main goal is seeking separation of wages between the loyal employee with years of knowledge and service from the employee just joining our department. Discussion. Motion by Sleger to forward the request made by the jailer group onto the Human Resources Committee to analyze and make a suggestion for resolution. Seconded by Drew. Motion carried.
- 5) Software Comparisons (Spillman and Zuercher). Chief Deputy Kuhl explained that many staff hours have been committed to this information gathering project to include meetings, demos, and site visits to select the best software for the future of the Sheriff's Office. Both companies have great products. Making a decision for 2018 is critical due to what seems to be price-bidding right now. Sheriff Richards commended all of his involved staff, but specifically CD Kuhl and MIS Bev Enke for their dedicated and diligent work on this research project.
