ADRC TRANSPORTATION PROGRAM UPDATE

There were 45 declined rides in 2022. Of those, 64% were due to being full, the remaining were due to appointments that were outside of the transportation window, on holidays, or were bariatric requests. There was an increase in transports for the Pardeeville and Wisconsin Dells area. We also have been providing transports for the Randolph and Merrimac areas. The ADRC has opened up to providing non-medical transports to grocery stores, haircut appointments, etc. A plan is being worked on to provide group transportation to the congregate meal sites on days when activities are being held.

5310 GRANT

The ADRC was not approved for the bariatric van. This was due to a lack of funding. There were two awards that were granted last year. The goal is to use both of those awards along with a funding match to purchase a bariatric van. This process has to go through approvals to use the funds. The van would be a rear-load van with a winch system. A suggestion was made to get a van that can at least accommodate a 36" wheelchair.

5 - YEAR COORDINATED PLAN DISCUSSION

There was a suggestion to reach out to area organizations to let people know what the ADRC does and to inform of things we cannot do without community involvement.

2024-2028 COORDINATED PLAN DISCUSSION

A suggestion was made for customers to be able to schedule appointments for themselves for transportation online much like a restaurant reservation would be made. Another suggestion was to purchase a shuttle bus to be able to provide transportation to groups of people to non-medical activities.
