Anyone wishing to register to vote in Wisconsin has the following options:

1) BY MAIL

Up to 20 days before the election. Complete the registration form and mail it to your municipal clerk's office. You must include a copy of acceptable proof of residence. Note: You can start your voter registration form online at <https://myvote.wi.gov>. Your form must be printed, signed, and mailed or delivered, to your municipal clerk.



2) ONLINE

Up to 20 days before the election. Voters who have a valid WI Driver License or WI ID card issued by the DMV can register to vote online on the MyVote Wisconsin website: <https://myvote.wi.gov>. To register online, the voter must enter a name, date of birth, driver's license or ID number and address that matches what is on file with the WI DMV. If all of the fields match, the voter will be able to register to vote completely online without needing to print, sign or mail the form and without needing to send a proof of residence document. Voters who are not able to match their information with the information in the DMV database will be given the option to register by mail (see instructions above).



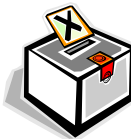
3) IN PERSON

Register in your municipal clerk's office up to 5:00 p.m. or the close of business, whichever is later, on the Friday before the election. (Call ahead for office hours.) NOTE: You must provide acceptable proof of residence.



4) AT THE POLLING PLACE ON ELECTION DAY

Register at the polling location on Election Day. NOTE: You must provide acceptable proof of residence. (You must have lived at your present location for at least 28 consecutive days immediately preceding the election.)



ACCEPTABLE PROOF OF RESIDENCE

Acceptable proof of residence documents must always include the voter's name and current address, and are any of the following:

- An unexpired Wisconsin Driver's License or State ID card.
- Any other official identification card or license issued by a Wisconsin governmental body or unit.
- Any identification card issued by an employer in the normal course of business and bearing a photo of the card holder, but not including a business card.
- A real estate tax bill or receipt for the current year or the year preceding the date of the registration.
- A university, college, or technical college identification card (must include photo) ONLY if the voter provides a fee receipt dated within the last 9 months or the institution provides a certified housing list, that indicates citizenship, to the municipal clerk.
- A utility bill (gas, electric, water, sewer, telephone/mobile, cable/satellite TV, internet, etc.) for the period commencing not earlier than 90 days before Election Day.
- Bank or credit card statement.
(NOT ACCEPTABLE: credit card offers or correspondence that is not an account statement; closing documents for purchase of home)
- Paycheck or paystub.
- A check or other document issued by a unit of government.
- A letter on public or private social service agency letterhead identifying a homeless voter and describing the individual's residence for voting purposes.
- Residential lease that is effective on date of registration. (Not valid if registering by mail.)
- An intake document from a residential care facility such as a nursing home or assisted living facility.

This is not a comprehensive list, but categories of the most common types used by voters.
