Joint Executive, Finance, Human Resources and Public Safety Committee Minutes December 20, 2023

The joint meeting of the Executive, Finance, Human Resources and Public Safety Committees was called to order by Chair Polzer at 8:30 a.m. A quorum from all committees was present. The meeting was properly noticed as required by the Wisconsin Open Meetings Law. The meeting was held at the Administration building, Meeting Rooms #113-114, 112 E. Edgewater Street, Portage, Wisconsin.

Resolution: Sheriff's Sworn Union Contract Amendment 2024-2025 Wage Table

The proposed wage table was reviewed. Discussion followed regarding the additional 50 cents added to the 8-year step for 2025. Burmania explained the formula used to determine the hourly rate was to apply the 3% to the base rate then add the additional 50 cents. Brandner stated the Sheriff's Union understood the wage to be 3% applied to the adjusted rate (with the 50 cents included from the previous year). The adjusted rates would be as follows for 2025 8-year step:

Deputy: 41.013 (changed from 40.498); Sergeant: 43.655 (changed from 43.140)

The total cost of the amendment for 2025 would be \$134,030 (changed from \$110,970 as stated in the resolution, lines 20 and 31)

Motion by K. Miller to approve the resolution to adopt the amended 2024-2025 Wage Table to include the changes to the 2025 wages for the 8-year step as discussed. Second by M. Rohrbeck. Motion carried.

Motion by M. Rohrbeck to adjourn the meeting. Second by Brusveen. Motion carried. The Joint Committee meeting was adjourned at 8:50 a.m.
