Chair Foley called the meeting to order at 9:02 a.m. The meeting was properly noticed and published.

# **AGENDA**

MOTION: Motion made by Hutler, second by Wingers to approve the agenda as written. The motion was unanimously approved.

### **MINUTES**

MOTION: Motion made by Konkel, second by Ross to approve the Highway Committee minutes of July 7, 2016, and July 15, 2016. The motion was unanimously approved.

### **VOUCHERS**

The Committee reviewed the voucher report detailing payments made from June 30, 2016 through July 27, 2016.

MOTION: Motion made by Konkel, second by Wingers to approve the vouchers for a total of \$442,337.35. The motion was unanimously approved.

# COUNTY STP ROAD AND BRIDGE

Status of current STP road and bridge projects was shared with the Committee. Additionally, Hardy provided a timeline for planned improvements on state highways within Columbia County.

## CAPITAL IMPROVEMENT PLAN

Hardy presented the 2016 capital improvement plan. At the previous meeting, \$7,761 for the purchase of the Phoenix Fuel Management software was approved by the Committee. Cost savings from other capital outlay items provided funding for the software. Hardy requested to reinstate the originally budgeted maintenance management program to cover MIS programming and upgrade to the Phoenix software.

MOTION: Motion made by Wingers, second by Ross to move \$22,239 from remaining excess in the capital outlay plan to maintenance management program for additional MIS programming. The motion was unanimously approved.

### 5 YEAR COUNTY ROAD PLAN

Hardy provided information on the overall condition of county trunk highways. He presented a five year plan for paving projects, crackfilling, sealcoat projects, and general maintenance.

# 2017 HIGHWAY DEPARTMENT BUDGET

The Committee reviewed each individual 2017 budget request and made motions for each one separately.

MOTION: Motion made by Konkel, second by Hutler to approve 3110 Highway Administration budget with a County Appropriation request of \$188,432. The motion was unanimously approved.

MOTION: Motion made by Konkel, second by Wingers to approve 3191 Supervision budget with a County Appropriation request of \$135,437. The motion was unanimously approved.

MOTION: Motion made by Ross, second by Hutler to approve 3192 Radio Expenses budget with a County Appropriation request of \$13,702. The motion was unanimously approved.

MOTION: Motion made by Wingers, second by Ross to approve 3193 General Public Liability budget with a County Appropriation request of \$96,999. The motion was unanimously approved.

MOTION: Motion made by Wingers, second by Konkel to approve 3311 C.T.H Maintenance budget with a County Appropriation request of \$1,136,550. The motion was unanimously approved.

MOTION: Motion made by Konkel, second by Wingers to approve 3312 C.T.H Maintenance budget with a County Appropriation request of \$1,847,400. The motion was unanimously approved.

MOTION: Motion made by Hutler, second by Ross to approve 3328 Road & Bridge Constr. on State Hwys budget with a County Appropriation request of \$0. The motion was unanimously approved.

MOTION: Motion made by Wingers, second by Hutler to approve 3331 Maintenance – Towns, Villages, Cities budget with a County Appropriation request of \$0. The motion was unanimously approved.

MOTION: Motion made by Hutler, second by Wingers to approve 3333 County Aid Road Construction budget with a County Appropriation request of \$167,224. The motion was unanimously approved.

MOTION: Motion made by Hutler, second by Wingers to approve 3334 County Aid Bridge budget with a County Appropriation request of \$20,331. The motion was unanimously approved.

MOTION: Motion made by Konkel, second by Ross to approve 3371 Miscellaneous Projects/Inventory Sales budget, which includes projects using funding from the ATC environmental impact fee payment, with a County Appropriation request of \$0. The motion was unanimously approved.

MOTION: Motion made by Hutler, second by Ross to approve 3390 County Parks budget with a County Appropriation request of \$36,400. The motion was unanimously approved.

General revenues for 2017 were budgeted for \$3,154,343. The Highway Department is requesting a total tax levy of \$4,963,757, which is an increase of \$172,637 from the 2016 budget.

MOTION: Motion made by Ross, second by Hutler to approve the request 2017 tax levy of \$4,963,757. The motion was unanimously approved.

## CAMBRIA SHOP PROJECT STATUS

Hardy provided an update on the status of the Cambria shop project. An expenditure report was provided to the Committee. Anticipated occupancy date is October 3, 2016.

Hardy presented a change order from Cardinal Construction for a deduction of \$645. Schaper will be installing the concrete fuel pad instead of Cardinal. These funds will be transferred to the contingency allowance.

MOTION: Motion made by Konkel, second by Wingers to approve the Cardinal Construction change order and transfer \$645 to the contingency allowance.

# <u>COLUMBIA COUNTY FEE ORDINANCE (TITLE 9-1-8) REVISION – RIGHT OF WAY</u> PERMITS

The mowing exclusion was added to the Title 9-1-8 Highway and Transportation Fees ordinance addition for right-of-way work permits. The Committee at the previous meeting approved the additional fee. This revision will be presented at the next Executive Committee meeting.

## COLUMBIA COUNTY HIGHWAY ACCESS ORDINANCE (TITLE 12-4)

Additional revisions have been made to Title 12-4 Highway Access Control Ordinance.

MOTION: Motion made by Konkel, second by Ross to approve Title 12-4 Highway Access Control Ordinance revisions as presented. The motion was unanimously approved.

# **VACANT POSITION UPDATE**

Hardy provided an update on filling vacant positions.

One new worker's compensation claim was reported and discussed with the Committee.
