#### **VOUCHERS**

The Committee reviewed the voucher report detailing payments made from July 28, 2016 through August 24, 2016. Schneider provided input regarding some of the uncommon expenditures.

MOTION: Motion made by Hutler, second by Wingers to approve the vouchers for a total of \$365,406.77. The motion was unanimously approved.

### SKID STEER, GRAPPLE BUCKET, AND TRAILER BIDS

Bids for a skid steer, grapple bucket, and trailer were opened and read aloud. Commissioner and Fleet Manager will review specifications for all bids and present a recommendation prior to the Highway Committee road tour scheduled for September 8, 2016.

#### CAPITAL IMPROVEMENT PLAN

Hardy reviewed the 2016 capital improvement plan and remaining outlay items to be purchased.

#### 2016 EQUIPMENT DISPERSALS

A list of equipment that will be sold this fall through Wisconsin Surplus Online Auction was presented to the Committee.

#### 2017 BUDGET REVISION

Schneider discussed a formula error that was included in the 2017 proposed budget that the Committee approved during the August meeting. The 2017 County Aid Bridge Budget Request should have been \$30,654. Revising this amount will increase the 2017 levy request by \$10,323 to \$4,974,080.

MOTION: Motion made by Konkel, second by Wingers to approve the revision increasing the 2017 County Aid Bridge Budget Request to \$30,654 and the total levy request to \$4,974,080. The motion was unanimously approved.

## INSURANCE TRACTOR AND MOWER REPLACEMENT

Hardy explained that the County's insurance company determined a tractor and mower consumed by fire as a total loss. The committee reviewed and discussed details of the incident. Hardy asked the Committee for direction whether to pursue a new or used tractor replacement.

MOTION: Motion made by Konkel, second by Hutler to proceed with replacing the lost units with a new 10' batwing mower and a new tractor. The motion was unanimously approved.

#### CAMBRIA SHOP PROJECT STATUS

Hardy provided an update on the status of the Cambria shop project. An expenditure report was provided to the Committee.

Hardy presented a change order from Cardinal Construction to add \$5,957 to the construction contract for a block retaining wall and a concrete slab outside of the west end door. Funds will be transferred from the contingency allowance leaving \$14,688 remaining in the allowance.

MOTION: Motion made by Hutler, second by Wingers to approve the Cardinal Construction change order and transfer \$5,957 from the contingency allowance. The motion was unanimously approved.

#### VACANT POSITION UPDATE

Hardy provided an update on filling vacant positions.

## POSITION REPLACEMENT REQUEST – EQUIPMENT OPERATOR

Hardy presented a position replacement request a for vacant Equipment Operator position. This position will be vacant as of September 29 due to a retirement.
