### RESOLUTION-APPLY FOR CDBG-EAP FUNDS-SOUTHERN HOUSING REGION

Kari Justmann (MSA) discussed the approximately 1,200 owner-occupied homes that were damaged or destroyed by storms in Kenosha County on July 11-12, 2017. There is federal money available under the Wisconsin Small Cities Community Development Block Grant-Emergency Assistance housing program, administered by the State of Wisconsin, Department of Administration, and division of Housing, for the purpose of housing activities. Columbia County is the lead county for the Southern Housing Region Program, which includes Kenosha County. There are administration dollars setup so there is no cost to the communities.

Motion: On motion by Cupery, second by Weyh, the Committee approved that an application be submitted to the State of Wisconsin for the following projects: Owner-Occupied and Rental Housing Rehabilitation and Replacement of Homes Damaged in Kenosha County on July 11-12, 2017.
