Project RT #2

The Committee reviewed a request for rental property rehabilitation. Under program guidelines, the property landlord who submitted the application is eligible for funds from the program, as long as the renters qualify.

The Randolph property is 50 years old, and home to a very-low-income family with a female head of household and children not under the age of six.

Review Loan Application - Cardinal Country Daycare, LLC

The Committee reviewed an application from Donald and Jo Marie Johnson of Cardinal Country Daycare, LLS. The Johnsons are requesting funds to build a new daycare center in the Village of Fall River. The Johnsons currently own a successful daycare center in the City of Columbus and are hoping to expand with the new facility. The Johnsons, CPA Carol Valley, and Randy Bobholz of Farmers and Merchants Union Bank joined the meeting to review/discuss the project.

Review Loan Application - Cardinal Country Daycare, LLC, continued

The project request includes funds for land and construction, furniture/equipment, working capital, and start up costs for a total of \$230,000 with an additional \$720,000 obtained from private lenders. An estimated 24 full-time positions, and 6 – 11 part-time positions will be created with this project, meeting loan program requirements.

The Committee considered the proposal and questioned the labor market, staff credentials, pay scale, rates, hours of operation, and financial statements. Schepp noted that an environmental assessment had to be completed before the proposal could be finalized.

The Johnsons, Valley, and Bobholz exited the meeting. Further review of the project application continued.

On motion by Baumgartner, second by Hamele, the request was approved for a total of \$230,000. The motion was not unanimous, with Martin voting no.
