Key COVID-19 Data Summary for Columbia County as of January 14th 10:00 a.m.

- Total confirmed positive test results: 4536 (+194 since 1/6/21)
(Includes active, recovered, deceased)
- Active cases: 212 (+17 since 1/6/21)
- Total probable test results 339 (+24 since 1/6/21)
- Total ever hospitalized 228 (+12 since 1/6/21)
- Individuals recovered: 4,288 (+174 since 1/6/21)
- Total deaths of people confirmed positive: 35 (+2 since 1/6/21)
- Total deaths of people probable results 6 (+0 since 1/6/21)
- Total negative cases: 24615 (+410 since 1/6/21)
- Total number of active investigations by setting: 43 (+2 since 1/6/21)
Educational facility -12; Long-term care facility -7; Workplace (non-health care) -17; Group housing facility -1; Health care facility -3; Other setting -3.

What age groups in Columbia County are testing positive for COVID-19?

As of 1/14/2021 at 10:00 a.m., the 4173 persons testing positive per age group were:

0-9 years old- 163 persons (3.6%)	50-59 years old – 769 persons (17.0%)
10-19 years old – 505 persons (11.1%)	60-69 years old – 486 persons (10.7%)
20-29 years old – 770 persons (17.0%)	70-79 years old – 265 persons (5.8%)
30-39 years old – 753 persons (16.6%)	80-89 years old – 113 persons (2.5%)
40-49 years old – 676 persons (14.9%)	90 plus years old – 36 persons (0.8%)
