Key COVID-19 Data Summary for Columbia County as of March 24th

- Total confirmed positive test results: 5,149 (+31 since 3/17/21)
(Includes active, recovered, deceased)
- Active cases: 42 (+3 since 3/17/21)
- Total probable test results: 380 (+1 since 3/17/21)
- Total ever hospitalized: 282(+1 since 3/17/21)
- Individuals recovered: 5,050 (+27 since 3/17/21)
- Total deaths of people confirmed positive: 56 (+1 since 3/17/21)
- Total deaths of people probable results: 12 (0 since 3/17/21)
- Total negative cases: 26,962 (+99 since 3/17/21)
- Total number of active investigations by setting: 18 (+4 since 3/17/21)

30-39 years old – 840 persons (16.3%)	80-89 years old – 130 persons (2.5%)
40-49 years old – 762 persons (14.8%)	90 plus years old – 40 persons (0.8%)
