WHEREAS, the Wisconsin Legislature has established a "Smart Growth Law" that requires the Town of Fountain Prairie to develop a comprehensive plan in accordance with Chapter 66.1001 of the Wisconsin State Statutes, and

WHEREAS, the Town Board of the Town of Fountain Prairie has assigned the developing of a plan consistent with the requirements specified by law to the Town of Fountain Prairie Plan Commission, and

WHEREAS, the governing local body of a local government unit shall adopt written procedures that are designed to foster public participation during the preparation of comprehensive plan, and

WHEREAS, this resolution shall constitute the written procedures designed to foster public participation in accordance with Chapter 66.101(4)(a) of the Wisconsin State Statutes:

THEREFORE, BE IT RESOLVED that public participation in the development of the Town of Fountain Prairie Comprehensive Plan may include, but not be limited to the following activities: a County community opinion survey, Town public meetings, news releases, radio addresses, Town of Fountain Prairie Plan Commission meetings and other open meetings for which the public is entitled to have advanced notice. In addition, all informational items used and produced by the Town of Fountain Prairie Plan Commission shall be made available for public review at the Columbia County Planning and Zoning Department and at the Town of Fountain Prairie Town Hall.

ORDINANCE NO. FPORD-2000-001

THE TOWN BOARD OF THE TOWN OF FOUNTAIN PRAIRIE, COLUMBIA COUNTY, WISCONSIN, HEREBY ORDAINS AS FOLLOWS:

Section 1: The Town Board of the Town of Fountain Prairie, Columbia County, Wisconsin, hereby amends the Municipal Code of the Town of Fountain Prairie by the addition of the following:

CREATION OF A TOWN PLAN COMMISSION. A Town Plan Commission is hereby created pursuant to Sections 60.62(4)(a) and 62.23(1)(a) of the Wisconsin Statutes.

- Purpose. The Town Plan Commission shall make recommendations (a) to the Town Board regarding applications for permits, variances and changes to the Zoning Ordinances of the Town of Fountain Prairie.
- Members. The Town Plan Commission shall consist of five (5) (b) members, all of whom shall be appointed by the Town Board chairperson. The Town Board chairperson may appoint himself or herself to the Town Plan Commission and may appoint other town elected or appointed officials to the Town Plan Commission EXCEPT that the Town Plan Commission shall always have at least one (1) citizen member who is not a town official.
- The number of members of the Modification in Number of Members. (c) Town Plan Commission may be modified pursuant to provisions of Section 62.23(1)(a) of the Wisconsin Statutes.
- Presiding Officer. The Town Board chairperson shall select the (d) presiding officer for the Town Plan Commission.
- Statutes Adopted. All applicable provisions of Sections 60.62, (e) 61.35 and 62.23 of the Wisconsin Statutes shall apply to the Town Plan Commission.

TOWN OF FOUNTAIN PRAIRIE ORDINANCE NO. 07-01 AN ORDINANCE ADOPTING THE TOWN OF FOUNTAIN PRAIRIE COMPREHENSIVE PLAN

Recitals

- A. Pursuant to sections 60.22(3) and 62.23(2) and (3), Wisconsin Statutes, the Town of Fountain Prairie is authorized to prepare and adopt a comprehensive plan as defined in sections 66.1001(1)(a) and 66.1001(2), Wisconsin Statutes.
- B. The Town of Fountain Prairie Town Board adopted and followed written procedures designed to foster public participation in every stage of the preparation of the comprehensive plan as required by section 66.1001(4)(a), Wisconsin Statutes.
- C. The Plan Commission of the Town of Fountain Prairie, by a majority vote of the entire Commission recorded in its official minutes, adopted a resolution recommending to the Town Board the adoption of the document entitled "TOWN OF FOUNTAIN PRAIRIE COMPREHENSIVE PLAN 2030" (the "Town of Fountain Prairie Comprehensive Plan"), which contains all of the elements specified in section 66.1001(2), Wisconsin Statutes.
- D. The Town of Fountain Prairie held a public hearing December 20, 2007, at which a proposed comprehensive plan was discussed, in compliance with the requirements of section 66.1001(4)(d), Wisconsin Statutes, and provided numerous other opportunities for public involvement per its adopted public participation strategy and procedures.

Ordinance

Therefore, pursuant to section 66.1001(4), Wisconsin Statutes, the Town Board of the Town of Fountain Prairie do ORDAIN as follows:

- 1. The document entitled "TOWN OF FOUNTAIN PRAIRIE COMPREHENSIVE PLAN 2030" is adopted as the Town of Fountain Prairie Comprehensive Plan under section 66.1001 of the Wisconsin Statutes.
- 2. The Town Clerk is directed to file a copy of this Ordinance and the Town of Fountain Prairie Comprehensive Plan with all of the entities specified in section 66.1001(4)(b), Wisconsin Statutes.

3. This Ordinance shall take effect upon passage by a majority vote of the members-elect of the Town Board and publication/posting as required by law.

The foregoing Ordinance was duly adopted by a majority vote of the members-elect of the Town Board of the Town of Fountain Prairie at a meeting held on November 15, 2007.
